


## Community Spread Benchmarks

The Centers for Disease Control and Prevention (CDC) released updated guidance for the safe delivery of in-person learning based on the best-available evidence on February 26, 2021. The Maricopa County Department of Public Health is aligning its [K-12 school guidance and corresponding dashboard](#) with the most current recommendations available, and following Governor Ducey’s Executive Order 2021-4.
